Subject:- Upgradation of the school to Secondary level from the session 1980-81

Sir,

With reference to your letter No. Nil dated 8.8.80 on the subject cited above, I am to convey the approval of the Director of Education, Delhi for upgradation of your school from Middle school to Secondary level (Without grant-in-aid) from the session 1980-81 subject to the fulfillment of the following conditions:-

- 1) The requisite number of full time qualified teachers be appointed for class IX & X as well as in the middle department in the school.
- 2) All the employees should be paid prescribed pay scales and allowances.
- 3) Adequate Library facilities be made available in the school. And sufficient furniture be provided therein.
- 4) Science Laboratories should be properly equipped and separate well equipped Domestic Science Laboratory be arranged.
- 5) Adequate furniture be provided in the school for the students of various classes.
- 6) Regular and qualified Ministerial staff i.e. U.D.C. etc. and class IV staff-Peon, Sweeper and Chowkidar etc. be appointed immediately
- 7) The school shall comply with the provisions of Delhi School Education Act and Rules, 1973 and other instructions of the Department issued from time to time.
- 8) The school shall submit all returns in time and no fees shall be increased without prior approval from the Department.
- 9) Conditions already laid down vide recognition letter issued vide this office letter No.5347 dated 9.10.79 may also be fulfilled.
- 10) The compliance report may please be sent by 30.11.80.

Sub:- Upgradation of school from Secondary stage with effect from academic session 1992-93 (without aid).

Sir,

With reference to your application on the subject cited above I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing Middles/Sec school to Sec/Sr.Sec School level without aid w.e.f 1992-93 session subject to the fulfilment of the following terms and conditions:

1. That the school shall abide by the provision of DSEA & Rs, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Sr. Secondary classes.
4. That a proper library shall be established and facilities for reading-room/s hall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provision of section 10(1) of DSEA & Rs, 1973
7. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the premises of the school immediately, if any.
8. That the school shall dispense with the service of unqualified and over-aged staff, if any immediately.
9. That the service contract between the management and the employees be revised as DSEA & Rs, 1973 shall be executed immediately.
10. Fresh Health Certificate from MCD be obtained and produced to E.O for verification.
11. The Management committee shall regulate the functioning of school strictly in accordance with the provisions of DSEA & Rs, 1973.

12. Managing Committee of the school shall not start future academic session without prior approval of Director of Education which is a mandatory requirement under sub-section (1) of section 17 of DSE(A), 1973
13. That all the facilities presribed under rule 50 & 51 of the DSE(A), 1973 shall be made available to the students.
14. Proof to the effect that qualified staff has been appointed as per R.Rs be provided for the verification of E.C.
15. That staff has been paid all arrear and being paid as per Fourth Pay Commission. Proof be given to E.C. for verification.
16. That the arrangement for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
17. That the school shall comply with the norms of the CBSE for affiliation for examination purpose.
18. Medical facilities/leave, LTC, Bonus, Teaching Allowances, G.P.F etc. be paid since recognition of school.
19. Provident Fund register be maintained and each book be completed and shown to E.C. of the zone concerned for verification from time to time.
20. That the management of the school shall create a reserve fund of Rs 40,000/-
21. That the violation of any institutions/conditions/rules and regulation of the department shall lead to the withdrawal of recognition of the school.
22. That the science labs have to be improved/renovated by school latest by 31-8-1992
23. That in no case the school funds will be divested/transferred to any other fund/account of the society. The school funds will also not be utilised by the Society for any other purpose than the school.
24. That a report about fulfilment of the above conditions shall be sent to the E.C. every six month.
